

**Unilever Olly Sleep House Amazon Sweepstakes
Official Rules**

- **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND DOES NOT INCREASE YOUR CHANCES OF WINNING.**
- **VOID WHERE PROHIBITED BY LAW.**
- **ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION (SEE SECTION 13) AND ENTRANTS (EACH, AN “ENTRANT”) WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT (SEE SECTION 12).**

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES PARTIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The Unilever Olly Sleep House Amazon Sweepstakes (“Sweepstakes”) is open only to legal residents of the fifty (50) United States and the District of Columbia, who are (i) at least twenty-one (21) years of age, and (b) have or who create an Amazon.com account as of time/date of entry. Creating an Amazon account is free. Employees, officers and directors of Amazon.com Services LLC (“Sponsor”), Unilever PLC, US Health & Wellbeing, LLC, Realtime Media LLC (“Administrator”) and each of their respective parent companies, affiliates, subsidiaries, distributors, advertising, contest, fulfillment and marketing agencies (collectively, the “Sweepstakes Parties”), their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and their respective spouses, and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. In the event that a household, based on address, enters the Sweepstakes using more than five (5) unique email addresses, all of the Sweepstakes Entries associated with that household (determined by Sponsor or Administrator at their sole discretion) will be disqualified. All federal, state, and local laws and regulations apply. By participating in the Sweepstakes, you unconditionally accept and agree to comply with and abide by these “Official Rules” and the decisions of Sponsor and/or Administrator, including the interpretation of these Official Rules, administration of the Sweepstakes, selection of the winners, and Sponsor’s exercise of discretion, which will be final, non-appealable, and binding in all respects.
2. **TIMING:** The Sweepstakes begins at 9:00 a.m. Eastern Time (“ET”) on March 4, 2026 and ends at 11:59 p.m. ET on March 16, 2026 (the “Sweepstakes Period”). The designated computer clock of the Administrator is the official time-keeping device in the Sweepstakes.
3. **HOW TO ENTER:** There are two (2) ways to obtain entries in this Sweepstakes:
 - A. **Make a Purchase To Obtain an Entry Code:** During the Sweepstakes Period, purchase at least one (1) of the qualifying OLLY products listed in Appendix A of these Official Rules on Amazon.com to receive an “Entry Code” via email at the email address associated with your Amazon account:

Once you have received your Entry Code, follow the links in the email or directly visit <https://Ollysleephousesweepstakes.com> (“Website”). Log in with your Amazon.com Account credentials and follow the on-screen instructions to complete the registration form, including your email address, phone number, your full address, and your Entry Code to receive one (1) entry (an “Entry”) into the Sweepstakes, subject to the entry limit below.

Entry Codes may only be used once and only by one (1) person. Any attempt to obtain Entry Codes in excess of the limits set forth herein may result in disqualification. Entry Codes that are fraudulent, reproduced, altered, or obtained outside of authorized channels are not valid. NOTE: ANY FRAUDULENT ACTIVITY IN CONNECTION WITH THIS SWEEPSTAKES IS STRICTLY

PROHIBITED. IT IS FRAUDULENT TO PURCHASE ITEMS TO OBTAIN A SWEEPSTAKES ENTRY WITH THE INTENT TO RETURN THESE ITEMS AFTER THE SWEEPSTAKES ENDS. IF THE SPONSOR IDENTIFIES OR SUSPECTS THAT YOU ARE ENGAGED IN THIS OR ANY OTHER FRAUDULENT ACTIVITY, YOU WILL BE DISQUALIFIED.

- B. Free Alternate Method of Entry:** To receive an Entry without making a purchase/obtaining an Entry Code: legibly hand-print your full name, full mailing address (no P.O. Boxes), email address, phone number, and birth date on a plain piece of 3x5 inch paper ("Mail-In Entry") and mail it to Realtime Media, Attn: Unilever Olly Sleep House Amazon Sweepstakes (12312) Entry, 2460 General Armistead Ave, Suite 209, West Norriton, PA 19403. Each Mail-In Entry must be mailed separately in a hand-addressed, stamped envelope. No photocopied or mechanically reproduced entries will be accepted. Sponsor is not responsible for postage-due entries or for any incorrect or illegible data contained in any Mail-In Entry. Mail-In Entries must be postmarked no later than March 16, 2026 and received by March 21, 2026. All Mail-In Entries become the physical property of Sponsor and will not be returned or acknowledged. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries. You will receive one (1) Entry for each Mail-In Entry received by the Sponsor, subject to the entry limits below. Proof of submission does not constitute proof of receipt.

Entries and Mail-In Entries are referred to hereinafter as an "Entry". The Sweepstakes Parties are not responsible for technical difficulties of any kind, or for false, incorrect, changed, incomplete or illegible contact information.

LIMIT: One (1) Entry per person during the entire Sweepstakes Period, regardless of method of entry. Attempts made by the same individual to earn more than the stated number of Entries by using multiple or false contact information, accounts or otherwise may result in disqualification. Entries generated by artificial intelligence, script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive, or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Those who do not follow all instructions, provide the required information in their Entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified. Entries submitted by those who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. In the event of a dispute over the identity of an Entrant, Entry will be deemed submitted by the registered account holder of the email address associated with the Entry for the domain associated with the submitted address, provided that person is eligible. Any potential winner may be required to show proof of being the registered account holder. Registered account holder is defined as the person assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses. In the event that a dispute regarding the identity of the individual who submitted an Entry cannot be resolved to Sponsor's satisfaction, the affected Entry will be deemed ineligible.

- 4. SWEEPSTAKES DRAWING:** On or about March 23, 2026, the Administrator will select one (1) potential grand prize winner, one (1) potential first prize winner, and one (1) potential second prize winner in a random drawing from among all eligible Entries received in the Sweepstakes Period.
- 5. ODDS:** Odds of winning a prize depend on the total number of eligible Entries received during the entire Sweepstakes Period.
- 6. WINNER NOTIFICATION/PRIZE CLAIMING:** Each potential winner is subject to verification. The potential grand prize winner will be notified via phone using the information provided on the Entry form immediately after the random drawing. The Sweepstakes Parties are not responsible for and shall not be liable for incorrect, changed, or illegible contact information or for electronic communications that are undeliverable as a result of any form of active or passive filtering, or insufficient space in Entrant's

email or other account to receive messages. Sweepstakes Parties are not responsible for late, lost, intercepted, misdirected, or unsuccessful efforts to notify the potential winner. Notification is deemed to have occurred immediately upon the sending of an email by Administrator. As part of the winner notification process, the potential grand prize winner will be required to sign and return a declaration of eligibility/release of liability/prize acceptance agreement (“Declaration”), within twenty-four (24) hours from Administrator’s timestamp of notification, as a condition of receiving the grand prize. Additionally, the potential grand prize winner and their selected guest may each be subject to a background check before the grand prize is awarded. Sponsor reserves the right to disqualify the potential grand prize winner or guest based on the results of such background check if Sponsor determines in its sole discretion that awarding the prize to any such individual might reflect negatively on the Sponsor).

If any potential winner cannot be contacted within a reasonable time period, if any potential winner is ineligible, if any notification (including the Declaration) is returned undeliverable, if the potential grand prize winner fails or refused to sign the Declaration or declines the grand prize, if any potential winner fails to fully comply with these Official Rules, or any potential winner is otherwise found to be ineligible, such potential winner will forfeit that prize, and the applicable prize will remain un-awarded. A potential winner becomes an official “winner” only after verification of eligibility by Sponsor.

No more than the stated number of prizes will be awarded. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the number of each type of prize set forth in these Official Rules, the winners of the advertised number of prizes available may be selected in a random drawing from among all persons making purportedly valid claims for such prizes. Inclusion in such drawing shall be each entrant’s sole and exclusive remedy under such circumstances.

7. PRIZES/PRIZE RESTRICTIONS: The prizes to be awarded in this Sweepstakes are:

One (1) Grand Prize: The “Grand Prize” is a three (3) day/two (2) night trip for two (2) people – the winner and one (1) guest – to California to stay in the OLLY Sleep House. The trip includes round-trip coach class air transportation for the winner and guest from a major commercial airport near the winner’s residence (as determined by Sponsor) to an airport near the OLLY Sleep House; round-trip airport transfers while in California; and a \$600 prepaid card. The approximate retail value (“ARV”) of the Grand Prize is \$3,600. The actual value of the Grand Prize may vary depending on the point of departure, point of arrival, and fluctuations in the cost of air transportation. Any difference between the ARV and the actual value of the Grand Prize will not be awarded.

Travel must be taken on dates specified by Sponsor, which is currently expected to be April 3 – 5, 2026. The winner and their guest must travel on the same itinerary. If the winner resides within a 100-mile radius of the OLLY Sleep House, as determined by Sponsor in its sole discretion, ground transportation may be provided in lieu of air transportation, and no compensation will be provided for any difference in prize value. The winner and guest are responsible for having valid travel documents including a REAL ID or other government-issued identification approved for air travel. All airline tickets are subject to flight variation, work stoppages, and schedule or route changes. Sponsor reserves the right to structure travel routes, select hotels, and all other aspects of the prize in their sole and absolute discretion. The winner is responsible for all travel expenses not included herein, including airline baggage fees, gratuities, meals, and any other incidental costs or expenses related to participation in the Grand Prize. In the event the winner elects to take part in the Grand Prize without a guest, no additional compensation will be awarded in lieu of the unused Grand Prize components. The selected guest must be at least twenty-one (21) years of age. Once a guest is selected, they may not be substituted, except in Sponsor’s sole and absolute discretion. The guest must sign and return a travel liability release and publicity release before travel will be booked. The winner and guest hereby acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any part of a Grand Prize. No changes will be made to travel details once any element of the travel arrangements have been booked, except at Sponsor’s sole discretion. Any damage to the OLLY Sleep House during prize stay will be the responsibility of the winner. Sponsor bears no responsibility if any event, element, or detail of the Grand Prize is canceled, postponed, or becomes

unavailable for any reason whatsoever by the air carriers, venue operators, transportation companies, prize providers, or any other persons providing any Grand Prize-related services or accommodations. Sponsor is not liable for any missed Grand Prize events, or expenses incurred as a consequence of flight cancellation/delay or ground transportation delay. No refund or compensation will be made in the event of the cancellation or delay of any transportation or other Grand Prize element except at the sole and absolute discretion of Sponsor. Should any event, element, or detail of the Grand Prize become unavailable, the Sponsor shall have no obligation to the winner aside from providing the remaining portion of the Grand Prize, minus any unavailable event, element, or detail. The Sponsor and/or any other venue operations management reserves the right in its sole discretion to remove or to deny entry to the winner and/or guest if either winner or guest engages in an obnoxious, inappropriate, illegal, unsafe, or otherwise disruptive manner, or with intent to create an unauthorized disturbance or interruption, or to otherwise annoy, abuse, threaten or harass any other person while partaking in the Grand Prize.

One (1) First Prize: The "First Prize" is an OLLY gift box, including a \$500 Amazon.com gift card and \$100-worth of Sponsor-selected OLLY and Unilever beauty products. All product selections are determined by the Sponsor in its sole discretion. The ARV of the First Prize is \$600.

One (1) Second Prize: The "Second Prize" is an OLLY gift box, including a \$250 Amazon.com gift card and \$100-worth of Sponsor-selected OLLY and Unilever beauty products. All product selections are determined by the Sponsor in its sole discretion. The ARV of the First Prize is \$350.

The total ARV of all prizes available in the Sweepstakes is \$4,550.00

Prizes are non-transferable, with no cash redemptions, equivalents, or substitutions except at Sponsor's sole and absolute discretion. All prize details not specified in these Official Rules will be determined in Sponsor's sole and absolute discretion. Prize details and availability are subject to change and are subject to applicable rules and restrictions. In the event that Sponsor is unable to provide a prize component, the Sponsor may, in its discretion, elect to provide winner with the approximate value of such item in cash or award an alternate prize of comparable or greater value. Prizes are awarded "AS IS" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Each winner will be solely responsible for all federal, state, and/or local taxes, and for any other fees or costs associated with the prize received, regardless of whether it, in whole or in part, is used. The value of the Grand Prize will be reported for tax purposes as required by law. The Grand Prize winner will be required to provide Sponsor with a valid social security number via an IRS W-9 Form before the Grand Prize will be awarded for tax reporting purposes. An IRS Form 1099 will be issued in the name of the Grand Prize winner for the actual value of the Grand Prize received. Any unclaimed prize will be forfeited. Prizes, if legitimately claimed, will be awarded. The Sweepstakes Parties are not responsible for and will not replace any lost, mutilated, or stolen prize or any prize that is undeliverable or does not reach a winner because of an incorrect or changed address. If a winner does not accept or use their entire prize, the unaccepted or unused part of such prize will be forfeited, and the Sweepstakes Parties will have no further obligation with respect to that prize. Administrator will contact the Grand Prize winner immediately upon winner verification to arrange travel booking. Sponsor will attempt to fulfill all properly claimed First Prizes within four (4) to six (6) weeks after winner verification.

8. **GENERAL:** Subject to applicable law, each winner hereby expressly grant to the Sweepstakes Parties and their respective successors, assigns, sublicensees and designees, the irrevocable right to use and publish their names, social handles, likeness (photographic or simulated), voice, biography and place of residence for all purposes, including, without limitation, advertising, marketing, promotional and publicity purposes in connection with this Sweepstakes ("Advertising"), in any and all media now or hereafter devised, worldwide, in perpetuity, without any form of notice, permission or any amount or kind of compensation, except for the awarding of the prizes to the winners. All copyright, trademark or other intellectual property rights in such Advertising shall be owned by Sponsor and/or its licensors, and each winner hereby disclaims and waives any claim of right to such Advertising. Such Advertising shall be solely under the control of Sponsor and/or its licensors, and each winner hereby waives any

claim of control over the Advertising content as well as any possible claims of misuse of winner's name, likeness or voice under contract, tort, or any other theory of law. The Sweepstakes Parties do not assume any responsibility for any disruption in the Sweepstakes, including, but not limited to, the failure or interruption of any social media platform or any internet service provider. In the event there is a discrepancy or inconsistency between disclosures and other statements contained in any Sweepstakes materials and the terms and conditions of these Official Rules, these Official Rules shall prevail, govern, and control. In the event Sponsor is prevented from continuing with the Sweepstakes by any event beyond its control, including, but not limited to, fire, flood, epidemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared), interference with the Sweepstakes by any party, or any federal, state, or local government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each, a "Force Majeure" event or occurrence), Sponsor shall have the right to modify, suspend or terminate the Sweepstakes or the prize. Sponsor additionally reserves the right, in its sole and absolute discretion to modify, suspend or terminate the Sweepstakes should causes beyond Sponsor's control corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes.

- 9. CONDUCT:** The Sweepstakes Parties are not responsible for the actions of Entrants in connection with the Sweepstakes, including Entrants' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity, or proper conduct of the Sweepstakes. The Sweepstakes Parties reserve the right, at their sole discretion, to disqualify (or terminate the prize of) any individual who is found to be, or suspected of, acting in any manner deemed by the Sweepstakes Parties to be in violation of the Official Rules, or to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person, or to be tampering with the Entry process or the operation of the Sweepstakes, and void all associated Entries and/or registrations. CAUTION: ANY ATTEMPT BY A USER, YOU OR ANY OTHER INDIVIDUAL TO DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAWS, AND SHOULD SUCH AN ATTEMPT BE MADE, THE SWEEPSTAKES PARTIES RESERVE THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES (INCLUDING ATTORNEYS' FEES) FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.
- 10. WAIVERS AND DISCLAIMERS:** The Sweepstakes Parties assume no responsibility or liability for: (a) lost, late, stolen, undelivered, inaccurate, incomplete, delayed, misdirected, damaged or garbled registrations, Entries, URLs, or emails; (b) any incorrect or inaccurate Entry information, or for any faulty or failed electronic data transmissions; (c) any unauthorized access to, or theft, destruction or alteration of Entries or registrations at any point in the operation of this Sweepstakes; (d) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, cable, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes; (e) inaccessibility or unavailability of the Internet or the website or any combination thereof or for computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of Entries, social networking posts, or registrations, the announcement of the prizes, or in any other Sweepstakes-related materials; or (f) any injury or damage to Entrants or to any other person's computer which may be related to or resulting from any attempt to participate in the Sweepstakes. If, for any reason, the Sweepstakes (or any part thereof) is not capable of running as planned for reasons which may include, without limitation, infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes which may corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, then the Sweepstakes Parties reserve the right at their sole discretion to cancel, terminate, modify or suspend the Sweepstakes in whole or in part. If terminated, the Sweepstakes Parties will award the prizes in a random drawing from among all non-suspect, eligible Entries received for the Sweepstakes up to the time of such action.

11. RELEASES: All Entrants, as a condition of participation in this Sweepstakes, release, discharge, indemnify and hold harmless the Sweepstakes Parties and each of their respective directors, officers, employees, agents, successors and assigns (collectively, "Released Parties") from and against any and all liability, claims, costs (including attorneys' fees), losses, damages, fines, or actions of any kind whatsoever for injuries, death, damages, or losses to persons or property which may be sustained, in whole or in part, directly or indirectly, in connection with: (i) participation in any aspect of the Sweepstakes (including travel to/from any Sweepstakes activity), (ii) the receipt, ownership, use or misuse of the prize awarded, including any travel associated with any prize, (iii) the Released Parties' violation of rights of publicity or privacy, claims of defamation or portrayal in a false light or based on any claim of infringement of intellectual property; (iv) Entrant's Entry form material on any related website, or (v) any typographical, human or other error in the printing, offering, selection, operation or announcement of any Sweepstakes activity and/or prize.

12. GOVERNING LAW AND LIMITATION OF LIABILITY: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Washington, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.

BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (A) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE SWEEPSTAKES, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (C) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

13. DISPUTE RESOLUTION: The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in the State of Washington, and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury, and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in the State of Washington. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in the State of Washington.
